## PRODUCT CHANGE NOTIFICATION

**Subject:** Qualification of Cypress Thailand as an Additional Assembly Site and PTI-SG as an Additional Wafer Bumping Site for Select 49-Ball Flip Chip BGA (FCBGA) IoT Products

**Change Type:** Major

### Description of Change:

Cypress announces the qualification of Cypress Thailand (BKK- 229, MOO 4, Changwattana Road Pakkred, Nonthaburi 11120 Thailand) as an additional assembly site for select 49-Ball Flip Chip BGA (FCBGA) IoT products. Cypress also announces the qualification of Powertech Technology Inc. Singapore (PTI-SG – 12 Ang Mo Kio Street 65, Singapore 569060) as an additional wafer bumping site for 40nm LP (Low Power) technology.

Compositions of the wafer bump material and dielectrics used for RDL are identical between Amkor Taiwan and PTI-SG. The 49-Ball FCBGA Pb-Free package is ROHS compliant.

**Qualification Status:**

This package has been qualified through a series of tests documented in the Qualification Test Plan QTP#184702. This qualification report can be found as an attachment to this PCN.

**Sample Status:**

Qualification samples may not be built ahead of time for all part numbers affected by this change. Please review the attached 'Affected Parts List' file for a list of affected part numbers with their associated sample ordering part numbers. Samples are subject to lead times of 30 days. If you require qualification samples, please contact your local Cypress sales representative as soon as possible, preferably within 30 days of the date of this PCN, to place any sample orders.

**Approximate Implementation Date:**

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of the affected part numbers in the attached file will be assembled at Cypress Thailand and wafer bumped at PTI-SG or other approved assembly and wafer bumping sites.

**Anticipated Impact:**

Products assembled at the new site are completely compatible with existing products from form, fit, functional, parametric and quality performance perspectives.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

**Method of Identification:**

The select 49-Ball FCBGA Pb-Free package assembled at Cypress Thailand carry enhanced traceability which allows each unit to be traceable to specific assembly equipment used to process that unit. The traceability is enabled using a serial number, called "unit code" which is top marked. This will in turn allow for faster response time to our customers.
