Subject: Cypress Standardized Customer Shipping Documents and Shipping Labels

Change Type: Minor

Description of Change:

As part of Cypress's Enterprise Resource Planning (ERP) system upgrade and entity structure consolidation project all standard customer shipping documents and labels will be standardized to a single format. This is a change from the current practice where the shipping documents and labels from former Spansion sites are different from shipping labels and documents from former Cypress sites. The consolidated labels and documents contain all the information found on both the Spansion documents and labels and the Cypress documents and labels. A set of representative documents and labels are contained in this notification.

Label size change: The standard bag and box labels will be standardized to 4.0" x 2.5". This is a change for the former Cypress locations where the current box and bag labels are 4.4" x 2.4". Standard shipping label size will be standardized to 4.0" x 8.5". This is a change for the former Cypress locations where the current standard shipping label is now 4.0" x 6.5" Note there is no change to the manufacturing labels.

Part Numbers Affected:

This notice affects all Cypress part numbers.

Approximate Implementation Date:

New labels and documents will be included with all orders shipped after February 14, 2018.

Anticipated Impact:

Customers will receive identically formatted documents and labels independent of which Cypress site ships product.
